

The U.S. Surgeon General recently released a report noting that over the last two years, rates of psychological distress among youth have sharply increased. One strategy recommended to counter these alarming trends is to, "Implement evidence-based programs that support children and increase their resilience. Examples include, youth enrichment programs such as mentoring."

In our work, we see firsthand the feelings of isolation, fear, and uncertainty that young people face. These stressors impact their self-esteem, sense of safety and ability to thrive. 



The Big Brothers Big Sister's one-to-one mentoring program matches caring adult volunteers with children to provide support, encouragement, and friendship. The matches develop a unique relationship based on their interests, hobbies, and values while spending time together in the community doing activities they both enjoy. This unique mentoring model encourages matches to gain new perspectives, new experiences, and a new friend whose impact lasts a lifetime.



BIG BROTHER JERRY AND LITTLE BROTHER JOHN

John's childhood has been more difficult than the average kid his age. At age seven, John and his younger sister were placed into foster care. The instability caused John to struggle in school which ultimately led him to repeat the first grade.

Luckily John's foster mom quickly became the caring and consistent adult he desperately needed. However, she began to realize that John would also need a strong male figure in his life to truly thrive. That's where Jerry comes in.

Big Brother Jerry and Little Brother John share a great love for sports, the outdoors, Imo's pizza—or let's be honest, all food. But most importantly, they share a deep connection and admiration for each other.

When the two first met, John was very shy and reserved, but it didn't take long for Jerry to see his hidden potential. When getting to know each other, Jerry discovered that John had never played catch before. In true Jerry fashion, he was determined to change that. Now any given weekend, you can find these two at a park enjoying an ice cream, followed by playing catch, shooting hoops, or hitting the batting cages.

Since being matched with Jerry three years ago, John has raised his grades, become more talkative, and has more trusting relationships with the adults in his life. While he still struggles from time to time, he knows he can always turn to Jerry to listen and understand.

John had decided very early on in the relationship that Jerry was the perfect match for him, and today that still rings true. Together the two have gained new perspectives while forming an unbreakable bond that will last a lifetime.

BIG & LITTLE OF THE YEAR

Abigail has not experienced an easy life. At the age of six, she had already been exposed to years of significant trauma. She lacked confidence and self worth. She was struggling in school and on the edge of being held back. This ultimately led Abigail's mother to reach out to Big Brothers Big Sisters. Little did she know that a new relationship with Big Sister Kimberly would lead Abigail to overcome the odds and pursue her childhood dreams of becoming a veterinarian.



In 2021, Big Sister Kimberly and Little Sister Abigail were awarded Big and Little of the Year - an award given to one match that exemplifies what the mentoring program is all about.

Last year, our team sat down with Kimberly and Abigail to talk about their decade long friendship.

How has Abigail inspired you as a Big?

Kimberly: "Abby has taught me alot about myself. She is a great example for others her age. She hasn't had an easy life...yet she's never given up. She strives to be better than what she came from."



How has mentorship supported your dream to become a veterinarian?

Abigail: "Kimberly has always supported the goal. When I was looking for colleges, she found John Logan for me. It's going to get me a head start. In two years I can have my vet tech degree. She's just been very helpful with everything. It's nice having someone who knows what they're doing."

What would you say to a potential mentor who is hesitant to volunteer?

Abigail: "For me, it's added more love into my life, which can never be a bad thing. It has definitely made me less shy and courageous. You never know what you can impact in a person's life. You might as well just give it a try!"

Kimberly: "There are so many young people out there who really need you. They need your guidance and support. I would say to any adult, just do it! I just can't say enough, it's really important."


BIG LEGACY SOCIETY
